

PROJECT ENGINEER'S REPORT

TOWN OF EASTEND WTP, RAW WATER RESERVOIR & INTAKE UPGRADES

BCL File #103.02-7B June 8, 2020

General Progress to Date

The project was awarded on May 4, 2020 to Westridge Construction Ltd. of Regina, SK for the tender amount of \$6,789,004.50.

In their April 7, 2020 tender, Westridge had originally projected a start date of 14 days after award of contract (tentatively April 21, 2020) and a construction completion date of 365 calendar days. However, since the project was over budget and the Town had to either secure additional funding or adjust the scope, it did not get awarded until May 4, 2020. Now that funding has been secured and the project was awarded, Westridge has now started work on the project. Based on the original construction timeframe of 365 days, the new substantial completion date is May 4, 2021.

Excavation of the proposed reservoir area and placement of the mud slab were completed as of June 5, 2020. During the next work period (month), construction is expected to include forming and placement of the bottom reservoir slab and beginning formwork of the reservoir walls. The underground piping and rough excavation of the raw water reservoir (pond) will also begin in June.

Progress Certificate

Progress No. 1 is certified and represents work completed to May 31, 2020. Westridge Construction Ltd. is eligible for payment in the amount of \$88,161.75.

Westridge provided their required WCB clearance paperwork along with their invoice.

Payment in the amount of \$8,825.00 should also be made to the holdback trust account, as required by the Builder's Lien Act. As this is the first progress payment, the holdback to date should be \$8,825.00.

Construction Schedule

A preliminary construction schedule (up to and including building close-up) was provided by Westridge on May 21. Based on the submission, the schedule looks to be an attainable one. Note that this schedule is subject to change based on weather and any other unforeseen factors but provides a baseline of the tasks to be completed. The schedule included the following milestones:

- September 24, 2020 Concrete reservoir completed
- October 21, 2020 Undergrounds, raw water reservoir and access road completed
- October 28, 2020 Building and finishes completed
- October 29, 2020 Mechanical and electrical installations begin
 - o Schedule will be updated on further details
 - o Treatment process installation will follow as well

There are several other suppliers that will be listed in the turnover documentation to ensure the operations staff at Eastend know where all equipment is from and where service and warranty services (after the one year Westridge warranty period) can be handled.

The Town, Westridge and BCL had a pre-construction meeting on May 11, 2020 to kick off the project and define some of the project requirements. Due to the COVID-19 restrictions on gatherings, the meeting was held via Zoom online conference. Present were:
