

**TOWN OF EASTEND
BYLAW No. 739/20**

A BYLAW TO REGULATE THE TOWN OF EASTEND TRANSFER STATION OPERATIONS.

The Council of the Town of Eastend, in the Province of Saskatchewan, enacts as follows:

1. Definitions:

- (a) "Disposal Ground" means the Municipal Transfer Station located on NW 29-06-21-W3m, Parcel No. 151547834
- (b) "Designated Areas" means separate sites within the disposal ground set aside for particular disposals
- (c) "Solid Waste Material" means untreated or unpainted wood, trees, shrubs, stumps, leaves, branches, grass clippings and discarded plants or trimmings from gardens or flower beds.
- (d) "Prohibited Waste" means household waste, appliances, treated or painted wood, animals or animal parts, furnaces, water heaters, concrete, all liquids such as paint, fuels, oils, chemicals or contaminated fluids, filters, batteries, furniture, explosives, electronics, metals including vehicles, fuel storage and propane tanks, tires, construction and demolition rubble, rocks, bricks and any other material not listed in subsection (c) as solid waste material.

- 2. The disposal ground shall function as a location for the disposal or collection of municipal solid waste material and shall be deposited in the designated areas.
- 3. Bagged solid waste material shall only be accepted in clear plastic bags.
- 4. The Town of Eastend shall establish hours of operation of the disposal ground, for the purpose of public use, forming part of this bylaw, known as Schedule A. Schedule A may be amended by resolution of council.
- 5. No person or persons, except authorized personnel, shall enter the disposal ground if the gate is locked.
- 6. No person or persons shall place, dump or dispose of any prohibited waste within the disposal grounds.
- 7. No person or persons shall place, dump, or dispose of waste or refuse of any kind near or over the gate at the disposal ground or on any public highway, street, lane, park, public place or water course.
- 8. No person or persons shall scavenge, disturb, remove or take away any material, object or thing from the disposal ground without written permission from the Council of the Town of Eastend.
- 9. No waste shall be burned at the disposal ground without special authorization and no person or persons except the supervisor or their delegate shall light a fire of any kind within the disposal ground.
- 10. No person or persons shall deface, destroy or alter any signs, gates or fencing at the disposal ground.
- 11. Any person who contravenes any provision of this bylaw shall be liable to a penalty as follows:
 - (a) First Offence: \$250.00 each
 - (b) All Offences thereafter: \$500.00 each
- 12. In addition to any penalty levied under this bylaw, the offender shall also be responsible for all costs incurred to rectify any damages or untidiness caused by the offence.

13. Any offender of any provision of this bylaw, upon being served with a Notice of Violation, may voluntarily pay the penalty at the Town of Eastend Municipal Office during regular office hours.
